POLITICAL SIGN REGULATIONS

- Any candidate, or his/her designee, or the proponents of a ballot measure who seek to utilize political signs, must first register with the Development Services Department on a City registration form.
- Political signs placed in the City may not exceed 16 square feet in area.
- There is no restriction as to the maximum number of signs placed in the City during an election.
- Political signs may only be placed on private property.
- Permission of the property owner where the political sign is to be displayed must first be obtained prior to placing the signs.
- Political signs are prohibited from being displayed on public facilities and rights-of-way, including any curb, gutter, sidewalk, utility pole, or parkway. No political sign shall be placed or affixed to a tree, fence, wall, post, equipment, nor any structure by any means.
- **Political signs may only be displayed within a 45 day time period preceding an election.**
- All political signs must be removed within 5 days following the election.
- The City will cause the immediate removal of any illegally placed political sign. In addition, the City may take legal action to recover all costs associated with the removal of illegally placed signs.
